**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the removal of risers associated with the abandonment of gas gathering line. The gas gathering line does not require registration per the latest COGCC flowline regulations, so we are associating this Facility Closure job with the nearest Location ID. Approximately 1.25 miles of gas gathering line will be abandoned-in-place. The riser, which we refer to as 2" Riser 6A, will be cut and capped per COGCC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. There is no associated Flowline Pre-Abandonment Notice Document number since gathering lines are not registered.

**PROPOSED SAMPLING PLAN****Proposed Soil Sampling**

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required.
