A site investigation will be conducted pursuant to COGCC Rule 911 at the MILLER T6N-R64W-S29 L01 Tank Battery location.

Grab confirmation soil samples will be collected from the produced water vessel excavation, beneath the ground oil tank, and at the separator. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Tank Battery and Produced Water Vessel Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

The source will be removed by conventional and/or hydro vac excavation as much as practicable. Excavation of impacted soil and confirmation soil sampling was completed in October 2022 and COGCC will be updated on the subsequent report.

REMEDIAL SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Before the excavation of impacted soil, nine soil borings were installed to delineate the vertical and lateral extent of soil impacts at the location. Excavation of impacted soil and confirmation soil sampling was completed in October 2022 and COGCC will be updated on the subsequent report. Excavation confirmation soil samples were collected and analyzed for Table 915 constituents (TPH, BTEX, 1,2,4 Trimethylbenzene, 1,3,5 Trimethylbenzene, Naphthalene, Polycyclic Aromatic Hydrocarbons [PAHs], pH, SAR, EC, Boron, and Table 915 metals). Eight of the soil boring(s) (MW-1 and MW-3 through MW-9) were improved with temporary PVC monitoring wells and sampled for Table 915 constituents in groundwater. NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to COGCC in a supplemental Form 27.

Groundwater will be sampled on a quarterly basis until analytical results are reported with concentrations of Table 915-1 analytes below regulatory limits for four consecutive quarters. Eight monitoring wells (MW-1 and MW-3 through MW-9) were installed and are sampled on a quarterly basis to monitor (natural) attenuation. Groundwater monitoring wells were sampled and submitted to a laboratory for analysis of Table 915-1 groundwater constituents: Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS).
