Erosion was repaired. Weeds were treated in June and July 2022, and salt cedar was removed. On 11/23, additional control measures were installed (water bars), northern disturbance was seeded, and amendments

Operator Comment: were applied. Per 2022 vegetation assessments, the greater reclaim meets 1003.e. standards, therefor maintenance was only completed on areas needing additional stormwater controls.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Approved pending re-inspection of this FIR resolution acknowledges the document was received. It is not an acknowledgement that the corrective action has been passed.

On 10/31/2022 Caerus submitted Form 4 document #403213897 which included a quantitative vegetation assessment indicating the interim areas of the location have achieved total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels.

A field inspection will be conducted at a future date to evaluate compliance with COGCC rules, and to assess interim area vegetation and confirm the findings in the quantitative vegetation assessment.

Inspector acknowledges Operator comments regarding installation of stormwater controls, although they are unrelated to this specific corrective action.
