NCRA will plug and abandon the subject well. NCRA proposes plugging the well by placing sand across the perforations at 5756-5760' and 5790-5800'. Three (3) sacks of cement will be spotted over the sand and approximately 3500' of casing will be pulled. A 50' cement plug will be set across the casing shoe at 322'. The surface casing will be cut off 4' below ground level and a steel cap will be welded on. The location will be reclaimed.
