On November 8, 2022, a release of produced water from a temporary water tank within secondary lined containment was discovered at the SBJ 22-13 HZ PAD location. Approximately 120 barrels of produced water were removed from the secondary lined containment. Cleanup activities are complete. A topographic Site Location Map showing the geographic location setting of the release is provided as Figure 1.
