Comments: This bradenhead test was performed on April 20, 2022 in response to a warning to perform Bradenhead testing on the well. Regrettably, the Form 17 was mailed in and not e-filed (due to technical deficiencies) and apparently lost. This was not realized until a recent violation was executed in Dec 2022, requiring subsequent bradenhead testing.

8-5/8" Surface Csg @ 274'; 4-1/2" production string @ 3243'; 2-3/8" tubing @ 3169'.
Bradenhead pressure went to 0 psi in 2 minutes. No pressure indicated during test.
