Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

The landowner discovered product at surface on his property and notified KPK of the release on May 15th, 2022. Operators mobilized to site, depressurized the line and shut in the well to eliminate chances of additional impacts being released, line failure was due to corrosion. KPK operators immediately began removing surface, to eliminate any mobile contamination. Upon the removal of mobile contamination KPK stopped work, and contacted SLR consulting for a Wildlife Biologist consultation on an eagles nest within a quarter mile of the release. The wildlife biologist consulted with Colorado Parks and Wildlife, and determined that the nest was currently abandoned work can proceed.

A steel flowline failed due to external corrosion at the 6 o'clock position. KPK was immediately notified of the release and dispatched crews to the site to shut in the line. A Hydrovac was dispatched to remove any residual product from the line and surface impacts to eliminate migration from the site. Excavation commencement will be based upon operator scheduling.
