A third-party environmental consultant/contractor will conduct environmental oversight and collect soil samples during decommissioning of the State #3, #4, #5 Tank Battery and removal of flowlines.

Grab soil samples will be collected as part of this initial site investigation during the decommissioning of the tank battery and flowlines. Soil samples will be collected in areas most likely to exhibit E&P waste impacts including beneath the aboveground storage tanks, partially buried produced water tank, loadouts, treater/separator, and along the length of flowlines.
