Comment:

Previous inspection #696203213 observed a pipeline on the east end of the Location cut/exposed and left at the surface; records and historic aerial imagery shows pipeline associated with O&G Location. Inspector required Operator to comply with 1004 rules; Remove remaining surface equipment/pipeline by 11/30/2021. Operator submitted FIR Resolution #403092201 indicating summit removed their unused line.

It was observed in this inspection that the previously observed pipeline remains on the east end of the Location. Pipe continues off location. Both on and off location portions of pipe must be removed. Original corrective action remains.

Livestock currently grazing reclaimed location; gate open. Grazing may impact success of revegetation.
