Operator Comment: Under the terms of the original Right-of-Way Agreement the landowner takes ownership of any equipment left on the premises if not in service for one year. The landowner has acknowledged these terms and will be arranging for the removal of the water storage tank and all other above ground appurtenances located on the ROW in the next 30 - 45 days. The tank and equipment depicted in the FIRR are of a water storage tank for water collected in the underground pipeline and is not a tank associated with a previous wellsite battery. The electrical box is associated with a tank battery operated by Kerr McGee Oil & Gas Onshore LP which was abandoned &

reclaimed several years ago. The landowner will also arrange for the removal of this equipment.

COGCC Decision: **Not Approved**

COGCC Representative: The tank and equipment are related to flowline operations of KPK. COGCC has consistently communicated to Operators that any equipment, regardless of ownership, is their responsibility to coordinate the removal.

As for the electrical box, COGCC Staff did initially write a corrective action to Kerr McGee Oil and Gas Onshore LP (Oxy) to remove. Oxy came back with information demonstrating they had similar equipment which they removed; therefore, it was determined it was equipment used for KPK operations. As stated above, it is the Operators responsibility to coordinate the removal of equipment.
