COGCC inspector Chris Binschus was notified post-Inspection 697502963 (where he cited multiple CAs for the subject location being improperly reclaimed) that Confluence DJ LLC would perform proper final reclamation for the Penrod 4-15-61S65W4SWSE location in the fall of 2021. Final reclamation for the subject location will commence on 11/18/2021. Confluence DJ will submit a FIRR for Inspection 697502963 stating the work that has taken place and will follow up with a Form 4 for final reclamation completed once vegetation reaches 80%.

Confluence DJ LLC is submitting a variance application to request that the access road remain open and are not reclaiming that portion of the location yet until we go to hearing and get a decision from the commission either way.
