The planned construction depth and static water level were not recorded. Domestic Well (DWR Receipt # 0465993, Permit 229379-) is approx 1120-ft to the SE. This well was constructed to 260-ft, with a static water level of 41-ft. Domesic Well (DWR Receipt # 396016, Permit 192916-) is approx 1275-ft to the SE. This well was constructed to 260-ft with a static water level of 51-ft.

Groundwater less than 20 ft is not expected at the disturbance location.

This location is within ¼ mile of a HPH Pronghorn Winter Concentration Area.

Grab confirmation soil samples will be collected from beneath the above ground oil tank, water tank, separator, and wellhead. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, metals, and EC, SAR, pH, and boron. Metals should not have been added to the soil analysis plan and should not have been included.
