The former production facility is permitted separately (Loc. ID 470236). All surface disturbance associated with Location ID 330773 was reclaimed in 2019 and has recently been superseded by gravel mining operations. The land is currently owned by LG Everist Inc. and the former well pad is within the active mining area, where the surface owner is managing environmental compliance and public health and safety under the Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board.
