Attention Chris Binschus:

A Form 10 Change of Operator was submitted under the API for the well to document PDC's acquisition of the site. The final-reclaimed facility is permitted separately (Loc ID 319365) alongside the P&A TIGGES # 31-18 Well, as identified in COGCC inspection Doc# 689300451 on 12/01/2017 and is located at 40.491800,-104.817990 as identified in COGCC inspection Doc# 673801142. The site was accessed via a preexisting crop perimeter road off CR 70. The crop perimeter road remains for its historic purpose. All portions of the disturbance associated with the TIGGES 18-13 Well have been fully reclaimed and returned to cropland.
