The Andrew Hop 1 well shared a pad with the associated production facility. The Well Site's designated final land use has changed from cropland to commercial. The historical disturbance area has been superseded by a campground as part of the Platte River Fort, and all disturbed areas have been compacted, covered, graveled, or revegetated, matching adjacent reference areas.
