Interim areas appear vegetated with introduced perennial grasses (crested wheatgrass) and occasional native shrubs (sagebrush, rabbitbrush, greasewood). If annual undesirable plant species and/or noxious annual weeds (cheatgrass) are present, they are not evident due to winter season and snow cover. A follow-up inspection will be conducted during a future growing season to determine compliance with 1003 requirements.
