A compromised fitting on the underside of a separator resulted in a currently unknown volume of produced fluids being released inside an unlined containment. The pooled fluid ignited and the flames caused equipment damage to the separator bank. There were no injuries associated with the incident. The pad was immediately shut in and the South Adams County and Brighton Fire Departments were dispatched to extinguish the fire. AFFF (PFAS) fire suppressant was not utilized.
