The eastern interim areas appear vegetated with introduced perennial grasses and native shrubs. Perennial grasses are not evident or sparse in western interim areas. Comment: Previous inspection #700702501 observed location shows signs of lack of stabilization/compaction and erosion around culvert on access road.

At the time of this inspection the location, access road and culvert are snow covered. It is unclear if previously observed stormwater issues have been addressed. It appears additional rock armoring may have been added around the culvert. A follow up inspection is required when snow is not obscuring the location. Corrective actions which have not been addressed remain applicable.
