At approximately 11:30 AM 12/24/22, Gunnison Energy field staff identified a release of produced water at the DGU Hotchkiss Federal 1289 Section 18 Pad. Approximately 280 barrels of produced water were released from a tank due to a frozen cracked pump suction line. The produced water did go outside the secondary containment but did not leave the location. The situation was controlled by 12:45 PM.
