INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the ROTH 12-30 wellhead cut and cap and flowline decommissioning. Approximately 90' of flowline that was abandoned-in-place due to field constraints will be removed. The wellhead was cut and capped per COGCC rules.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Five (5) grab confirmation soil samples were collected at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. Based on field observations, all five samples were submitted for waste characterization of COGCC Table 915-1 metals. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil.

Visual inspection of the flowline areas will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Flowline Closure and Wellhead Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Based on field observations at the time of the initial wellhead assessment, petroleum hydrocarbon odor and elevated organic vapor measurements were observed throughout the excavation. Based on soil analytical results, COGCC Table 915-1 organics and inorganics were in compliance. However, waste characterization of COGCC Table 915-1 metals was completed and found elevated concentrations of arsenic, barium, lead, and selenium exceeding local clean-up level and/or COGCC Table 915-1 protection of groundwater soil screening levels (GSSLs). A site assessment will be scheduled to delineate impacted media observed at the wellhead and determine the applicability of GSSLs. Noble proposes soil samples will be collected for analysis of arsenic, barium, lead, and selenium. Additional background samples for arsenic, barium, lead, and selenium are proposed to further compare residual metals at the site. If groundwater is encountered each soil boring will be completed as a monitoring well and the groundwater will be sampled for BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene.

No source is currently generated. A site assessment will be scheduled prior to December 31, 2022 to delineate impacted media observed at the wellhead and determine the applicability of GSSLs. Noble proposes soil samples will be collected for analysis of arsenic, barium, lead, and selenium. Additional background samples for arsenic, barium, lead, and selenium are proposed to further compare residual metals at the site.

REMEDIAL SUMMARY

A site assessment will be completed by December 31, 2022 to delineate impacted media observed at the wellhead and determine the applicability of GSSLs. The results of the assessment will be provided on a supplemental 27 and a remediation plan will be proposed as applicable. A NFA status will be considered when soil and/or groundwater is in compliance with applicable COGCC Table 915-1 regulatory limits and/or local clean-up considerations. A timeline for NFA will be proposed in a supplemental 27 following review of the site investigation data.
