SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

Well drilled to TD 5590'. 13-3/8" csg. set @ 159' KB and 7-5/8" csg. set @ 3718'. Tested and considered non-commercial.

We propose to plug and abandon the above well as follows:

- Set 10 sack cement plug @ 5360-5316' to isolate Morrison.
Set 10 sack cement plug @ 5220-5176' to isolate Dakota.
Set 10 sack cement plug @ 3700-3659' to isolate Niobrara.
Cut and pull 7-5/8" csg.
Set 24 sack cement plug @ 159-129' which is bottom of surface csg.
Set 5 sack cement plug in top of surface csg.
All intervening intervals to be filled w/9.1# rotary mud.

Request waiver of Regulation Dry Hole Marker as per the request of Landowner:

Csg. to be cut off below plow depth and capped.
