On September 12, 1966, set 100' cement plug from 3928 to 4028 with Halliburton. On November 1, 1966 started working 7" pipe for stretch and recovery. Shot off 7" casing at 1000' and pulled 1000' of 7". Set 20 sack cement plug @ 1000' on cut off and 10 sack plug at base of 9-5/8" surface casing and 10 sack plug in top of 9-5/8" casing with 4' x 4" dry hole marker.
