

SUNDRY NOTICES AND REPORTS ON WELLS CONSERVATION COMMISSION

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

Report of re-frac July 13, 1960.

TD 7516'. 7" casing to 6084'. 5 1/2" slotted liner (1518', top 130' blank) hung from 5995 to 7513. Slots from 6125 to 7513. Sand oil fractured 6125-7513. Sanded out after 8 mins. pumping time. Pumped into well 540 bbls gelled lease crude with adomite at 1/20 lb. per gal. loaded w/70,875 lbs. First 20,000# sand 40-60 mesh rest 20-40 mesh at 75 bbls per minute. Total sand into formation 38,875 lbs. sand. Treating pressure 2100# SI. Started treating at 1/2 lb. per gal. increased to 3-1/2 lbs. per gal. when sanded out. Shut In. Found top of sand in casing at 5045 feet. Cleaned sand out to 7513 feet. Total oil in frac job 1406 bbls lease crude. Currently pumping load oil.
