In accordance with Rule 218.b(1-7) Transfer of Operatorship Intent, Morning Gun Exploration, LLC (Morning Gun), Selling Operator, would like to inform the Colorado Oil & Gas Conservation Commission (COGCC) that Morning Gun will be transferring select assets to Buying Operator Summit Oil & Gas, LLC (Summit). The transaction is to be considered confidential and any other associated information confidential pursuant to 24-72-204(3)(a)(IV), C.R.S. Morning Gun and Summit submit this letter of attestation and associated documents to notify the COGCC of the transfer of assets.

Per Rule 218.a.(1), included as Attachment A is the Transferable Items list associated with this transaction. Both Operators agree to the transfer of operatorship of the attached list of Transferable Items and that the attached list of Transferable Items is complete. Summit has financial assurance in place to cover the bonding requirement to acquire these assets to their operatorship per Rule 703. The transfer occurred on June 4, 2021.
