**General Comment:**

On 12/19/2022, Reclamation Specialist Trujillo inspected Caerus Piceance's Colohan-67S96W 34NWSW location in Garfield County, Colorado.

During this inspection, a tank was observed on the north end of the Location missing required signage/labeling; labels that were evident stated "Laramie Energy LLC". Inspection was originally provided to both Caerus and Laramie, as this appeared to be a Laramie tank on a Caerus Location. Refer to inspection #696204526 for additional details.

After additional conversations with both Laramie and Caerus, it was confirmed that the tank does not belong to either Caerus or Laramie, rather the tank belonged to TEP, and is part of TEP's "gathering for location ID 334431. See document #402001089 for reference". See attached email communication for additional details.

Inspection and CA is now being provided to TEP: Please see photo #4 within the attached photo documentation. Refer to the "Location" section of this inspection report. Any corrective action(s) from previous inspections that have not been addressed are still applicable.

A follow up inspection on this site will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
