COGCC Inspection Report Summary

On Tuesday 1/17/2022, I, Inspector Scott Ramsey, conducted a routine inspection at TEP Porter Federal 16-29, at Location # 335118 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

During this inspection the following compliance issues were observed:

1. Random debris
2. Random staining
3. Unused/stored equipment (ECD is disconnected)
4. Open hole for wildlife to enter
