Description of Corrosion Protection

Fiberglass reinforced pipelines designed to withstand extremely high temperatures and any potential hydrogen sulfide or carbon dioxide concentrations. All water in the system is treated with corrosion inhibitor.

Description of Integrity Management Program

Proper design and construction of the flowlines taking into account any potential geo-hazards and design specifications are evaluated prior to installation. Annual testing, monthly audio-visual-olfactory (AVO) inspections, and all documents pertaining to inspections and maintenance will be retained for the lifecycle of the flow line or until the asset is divested to a different operator.

Description of the construction method used for public by-ways, road crossings, sensitive wildlife habitats, sensitive areas, and natural and manmade watercourses (i.e., open trench, bored and cased, or bored only), if applicable.

Flow lines were installed using a spider-plow to minimize any impacts to the areas being disturbed. The installation and backfilling are completed simultaneously and re-seeding and post-construction settlements were substantially reduced. The flow lines were installed adjacent to the county roads to minimize disturbance to surrounding contiguous vegetation.
