INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Decommissioning activities were completed at the Seltzer Farms-61S67W 3SEW production facility on August 12, 2022. Groundwater was not encountered during excavation activities. Visual inspection and field screening of soils one separator, one meter house, one produced water vessel (PWV), three dump line locations, one aboveground storage tanks (AST), and one emissions control device (ECD) was conducted following removal activities, and soil samples (SEP-B01 @3', SEP-B02 @3', PW-B01 @5', PW-W01 @2.5', AST-B01 @2') were submitted for laboratory analysis to determine if a release occurred. Laboratory analytical results for PW-B01 @5' indicated that naphthalene, total petroleum hydrocarbons (TPH), 1-methylnaphthalene (methyl), 2-methyl, arsenic, and barium impacts exceeding COGCC Table 915-1 were present at the former PWV location. As such, a Form 19 Initial/Supplemental Spill/Release Report (COGCC Document No.403137291) was submitted on August 18, 2022 and the COGCC issued Spill/Release Point ID 482926. The remaining analytical results for the soil samples collected were in compliance with COGCC standards and/or within the range of site-specific background levels. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data is presented in Table 1. The facility soil sample and field screening locations are illustrated on Figure 2 and 3.

From August 12, 2022 through October 31, 2022, excavation activities were conducted to address remaining soil impacts at the former PWV location, and seven (7) confirmation soil samples were collected from the base and sidewalls of the final excavation extent, at depths of approximately 9' and 7' bgs, respectively. The confirmation soil samples were submitted for laboratory analysis of naphthalene, TPH, 1-methyl, 2-methyl, arsenic, and barium using COGCC-approved methods. Analytical results indicated that constituent concentrations in the soil samples collected from the final excavation extents were in compliance with the applicable COGCC Table 915-1 standards and/or within the range of site-specific background concentrations. Soil analytical results are summarized in Tables 2 through 5. The laboratory analytical reports are provided as Attachment A.

On August 12, 2022, visual inspections and field screening of soils was conducted at visual inspections and field screening of soils was conducted at three sidewalls of the PWV excavation, the former meter house, 3 dump line locations, the former AST, and the former ECD. Based on the inspection and screening results, hydrocarbon-impacted soils were not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the COGCC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 through 5. The soil sample and field screening locations are illustrated on Figure 2 and 3. The laboratory analytical report is provided as Attachment A. The field notes and photographic log are provided as Attachment B.

Background soil samples PW-BG01@2.5', PW-BG02@2.5', PW-BG01@5', PW-BG02@5', PW-BG03@7', PW-BG04@9', and PW-BG05@9' were collected from native material adjacent to the produced water vessel excavation. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters and Table 915-1 Metals in Soils using standard methods appropriate for detecting the target analytes in Table 915-1. Between August 12 and October 31, 2022, approximately 10 cubic yards of impacted soil was excavated and transported to the Front Range Landfill in Erie, Colorado for disposal. The excavation area will be backfilled and contoured to match pre-existing conditions.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory data indicate that impacted soils in the excavation area have been remediated to be in compliance with the COGCC Table 915-1 standards and/or within the range of site-specific background concentrations. Groundwater was not encountered in the wellhead excavation area. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
