INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On May 4, 2022, a produced water release was discovered while conducting separator calibration. The line was isolated, and the leak was stopped. The release was confined to the working surface of the pad and was reported in a Colorado Oil and Gas Conservation Commission (COGCC) Form 19 Document 403038068. Initial site investigation was performed On May 19, 2022. Using a hydro vacuum truck, the point of release (POR) was exposed and identified as flowline associated with the westernmost separator. A total of four soil samples were collected and submitted for analysis of Table 915-1 soil constituents of concern to characterize and delineate the extent of soil impacts. Soil impacts are not currently delineated and warrant additional site investigation.

PROPOSED SAMPLING PLAN

Caerus proposes to advance approximately five soil borings using a hollow stem drill rig to delineate the vertical and horizontal extents of soil impacts related to the flowline failure. Background soil samples will be collected to characterize native levels of inorganic constituents around the site. Based on approved Form 27 Document 403077093 future soil samples will be submitted for the approved reduced analyte list of total petroleum hydrocarbons (TPH), xylenes, soil suitability for reclamation (SSR) constituents, and arsenic. See Document 403077093 and the associated attachments for details regarding site investigation efforts.
