

The following procedure is proposed to P&A the subject TA'd well:

- 1) Clean out anhydrite and shale to top of fish @ 1830'.
- 2) Pump 50 sx Class "H" cement on top of tubing fish.
- 3) Set 100' surface plug.
- 4) Pump 25 sx Class "H" cement down 8-5/8" x 5-1/2" casing annulus.
- 5) Cut off 8-5/8" casing and 5-1/2" casing at 2-3' below surface and weld steel plate across top of casing strings.
- 6) 9.5#/gal mud will be circulated between plugs.
