## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Once a release was discovered during purging operations on the 3DH separator, additional excavations were conducted, and impacted soil was removed and transported to a disposal facility. Volume of soil removed will be reported once finalized on a subsequent Form 27 Supplemental requesting closure. Transport and disposal records will be kept on file under usual and customary practice and are available upon request. Soil samples will be collected and analyzed for Table 915-1 constituents until the horizontal and vertical extents of the excavation are within COGCC Table 915-1 allowable limits.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Grab soil samples will be collected and field-screened from the base and each sidewall of the excavation. Soil samples will be collected and analyzed for Table 915-1 constituents until the horizontal and vertical extents of the excavation are within COGCC Table 915-1 allowable limits. Background samples will be collected from nearby native soils in areas not impacted by oil and gas activities and analyzed for EC, SAR, pH, and boron to establish background conditions for soil suitability.

### Proposed Groundwater Sampling

If groundwater is encountered during excavation activities, one sample will be collected and analyzed for Table 915-1 groundwater constituents BTEX, 1,2,4 and 1,3,5 Trimethylbenzene, and naphthalene.
