General Comment:

Spill was reported to COGCC by Fulcrum staff. COGCC inspected spill 483729 on 1/26/23. Weather was 8 deg, windy and overcast. The following was observed; it appeared that spilled fluid was contained inside secondary containment, water that was spilled was frozen inside the Lined secondary containment (dirt Berm). Valve that was froze was replaced. Fulcrum Field staff, Wes, was present and discussed the response with COGCC. Crews were planning on removing ice (produced water) and restore the secondary containment volume. At the time of inspection crews were removing the ice by chipping and shoveling, Wes mentioned that they may use hot water and vac trucks. Corrective action: file 10-day supplemental Form 19, Handle all spilled fluid and Ice as E&P waste. see attached Photos. well was pumping at time of inspection.
