Specifically, the items identified for Not Transferred, the operator was told, "The spills are all CL status, so those can stay under the Ursa operator number." The attestation included in this Form 9 has been executed, per COGCC, by the Delegated Agent who represents both "selling" and "purchasing" operator and who is a sole employee of TEP Rocky Mountain LLC. The purpose of this form is to facilitate proper transfer within the COGCC system, however it is not compliant per rule.
