I hereby certify all statements made in this form are, to the best of my knowledge, true, correct, and complete, and that the required components of the Oil and Gas Development Plan have been submitted pursuant to Rule 303.a.(7).

Desert Eagle Operating requests approval to amend the approved Red Rocks OGD (ID No. 480749) to add four new Oil and Gas Locations. Desert Eagle proposes to develop helium gas using a single exploratory conventional vertical helium gas well at each Oil and Gas Location. The well will be drilled with air. There will be no drilling mud, hydraulic fracturing, stimulation, or flowback. The well is not expected to produce hydrocarbons or water, based on results from wells already drilled in this area. The location will be in a remote area on private ranchland. If the well is developed for production, the location will contain only a wellhead. Helium gas will be piped underground to an off-location helium processing unit. Compressed helium will be loaded onto a tube trailer for transport by truck.
