Noarko Resources, Inc. is hereby making application to be allowed to commingle the Codell formation production with the Niobrara formation production in one well bore on this well. Notice of this application has been given to Martin Exploration Management Corp., 1919 14th Street, Suite 800, Boulder, Colorado 80302, the only operator within 1/2 mile.

Noarko Resources, Inc. proposes to set a retrievable bridge plug above the producing Codell formation, perforate the Niobrara formation, breakdown and ball-out with 7-1/2% HCL, stimulate the Niobrara formation, test the Niobrara for approximately 30 days and then remove the bridge plug and produce both formations through the same well bore. Attached is a detailed completion procedure and diagram for mechanical installation for this proposed commingling of the Niobrara and Codell Formations.

Noarko proposes to commence operations the week of February 11, 1985.
