Plants had gone to seed.</p> <p>Given the severity of the thistle infestation documented in inspection #692402386, dated 7/24/2020 and the presence of Scotch thistle with seedheads during this 1/26/23 inspection, it appears weed monitoring and management is necessary in the 2023 growing season.</p>
