Seals were replaced. Additional VRU was sourced and set on the location to handle more tank vapors. Due to the weather and electrician getting COVID last week finishing rigging in second VRU now. Some stained soil was stockpiled on location in containment and is scheduled to be hauled to Pawnee Waste on 02/07/2023. Will submit the manifest via a second FIRR or Sundry
