Operator Comment: The de minimus skim of oil reported on soil was located, scraped up and removed. The soil collected amounted to a couple shovel fulls.

In response to the denial of our initial FIRR filing:

Multiple visits and inspections to the site were completed at the time of release to verify any amounts of oil that were present were removed and disposed of. The resulting volume with staining was as stated previously adding up to couple shovels worth of material. When collecting, the only soil collected was the stained soil which was just the top one-eighth inch or so in each of these areas. Additionally I recall speaking over the phone to the inspector and informing that we would shut the well in until the berm was repaired and turn it back to PR once complete.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Inspector noted more that a couple shovel fulls of stained soil. Operator did say that he couldn't find all the areas noted in inspection by GPS.
