INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the plugging and abandonment of the Schneider 1-3 wellhead and the removal of the associated flowline. The flowline will be permanently removed. This form has also been prepared in accordance with COGCC Rule 911.a to provide prior notice of closure of the Schneider-62S46W/3SSW production facility. In accordance with COGCC Rule 911.a., soil and groundwater (if present) samples will be collected and submitted for laboratory analysis to determine if concentrations and values are in compliance with COGCC Table 915-1. Visual inspection and field screening of soils around the wellhead, associated flowline, and associated infrastructure will be conducted during sampling activities. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

Proposed Soil Sampling

Following wellhead cut and cap and facility decommissioning operations, soil will be field screened at the associated wellhead, separator riser, associated flowline, and surfaces and excavation areas. Samples will be collected if indications of impacts to soil or groundwater are present. If impacted soils are encountered, a soil sample will be collected from the area exhibiting the highest degree of impact based on visual, olfactory, and/or field screening observations. In the absence of apparent impacts, soil samples will be submitted to an accredited laboratory for analysis of BTEX, naphthalene, and total petroleum hydrocarbons (TPH), pH, electrical conductivity (EC), sodium adsorption ratio (SAR), and boron. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in COGCC Table 915-1. Proposed soil sample and screening locations are provided on Figure 2.

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene, using standard methods appropriate for detecting the target analytes in COGCC Table 915-1.

If no impacts are observed, a minimum of one soil sample from the wellhead, separator and wellhead riser excavations will be submitted for laboratory analysis of BTEX, naphthalene, total petroleum hydrocarbons (TPH), pH, specific conductance (EC), sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water soluble soil extract method. If impacts are encountered, a minimum of one soil sample will be submitted for laboratory analysis of the full COGCC Table 915-1 analytical suite.
