OPERATOR COMMENT

Analytical results from the confirmation soil sampling identified subsurface concentrations of arsenic, sodium adsorption ratio (SAR), and pH above the applicable COGCC Table 915-1 RSSLs. Entrada recommends the collection of a produced water sample to understand the chemistry of the produced water, specifically arsenic concentration and pH, and the collection of additional background soil samples to provide additional context for native SAR, Arsenic, and pH levels.

Entrada recommends that Summit file an initial Form 27 Remediation Workplan with the COGCC. Once the Form 27 is approved, a request for closure should be filed for the initial spill/release report Form 19 (Document #403203230). Any future work will proceed under the Form 27.
