INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Tank battery decommissioning activities were completed at the Miller X31-03, 06 O SA production facility on November 23, 2022. Groundwater was not encountered during facility decommissioning activities. Visual inspection and field screening of soils was conducted at the former production facility infrastructure locations following decommissioning activities, and six (6) soil samples were collected from the former separator (SEP), above-ground storage tank (AST), and produced water vessel (PWV) locations, at depths ranging from approximately 3 inches to 6 feet below ground surface (bgs). The soil samples were submitted for laboratory analysis of BTEX, 1,2,4- and 1,3,5-TMB, naphthalene, TPH-GRO (C6-C10), DRO (C10-C28), ORO (C28-C40), pH, EC, SAR, and boron, using standard COGCC-approved methods appropriate for detecting the target analytes. Additionally, based on field observations and preliminary analytical results, soil sample PW1-B01@6' was selected for waste characterization purposes and was submitted for laboratory analysis of the full COGCC Table 915-1 analytical suite using standard COGCC-approved methods. Laboratory analytical results indicated that soil impacts were present at sample location PW1-B01@6' due to TPH, TMB, and PAHs. As such, a Form 19-Initial/Supplemental Spill/Release Report (Document No. 403241050) was submitted on November 29, 2022, and the COGCC issued Spill/Release Point ID 483353. Analytical results indicate that the remaining constituent concentrations in the soil samples collected during facility decommissioning activities were in compliance with COGCC Table 915-1 standards and/or within the range of site-specific background levels or acceptable soil variability. A topographic Site Location Map is provided as Figure 1. Soil sample location and field screening data are presented in Table 1. The soil sample and field screening locations are illustrated on Figure 2.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

On December 5 and 7, 2022, excavation activities were conducted to address remaining soil impacts at the former PWV location, and 5 confirmation soil samples were collected from the base and sidewalls of the final excavation extent, at depths of approximately 9 and 8 feet bgs, respectively. Based on the analytical results for waste characterization sample PW1-B01@6', the confirmation soil samples were submitted for laboratory analysis of BTEX, TMB, TPH, PAHs, and pH. Analytical results indicate that constituent concentrations in the confirmation soil samples collected from the final excavation extents were in compliance with COGCC Table 915-1 standards. Soil analytical results are summarized in Tables 2 through 5.

Additional Investigative Actions

On November 23, 2022, visual inspection and field screening of soils was conducted at 3 sidewall locations within the PWV removal excavation area, 2 locations below the former ASTs, and 1 dump line removal pothole. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the COGCC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are presented in Tables 2 through 5. The soil sample and field screening locations are illustrated on Figure 2. The laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Background soil samples BG-01@3', BG-01@6', BG-02@3', and BG-02@6' were collected from native material adjacent to the former production facility. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters and Table 915 metals using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Tables 4 and 5.

SOURCE REMOVAL SUMMARY

On December 5 and 7, 2022, approximately 160 cubic yards of impacted material were removed from the excavation area and transported to the Kerr-McGee Land Treatment Facility in Weld County, Colorado for recycling. The excavation area was subsequently backfilled and contoured to match pre-existing site conditions.

REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory data indicate that impacted soils in the PWV excavation area have been remediated to be in compliance with the COGCCC Table 915-1 standards and/or within the range of site-specific background levels. Laboratory analytical results indicate that constituent concentrations in the remaining confirmation soil samples collected from the former production facility infrastructure locations were in compliance with COGCC Table 915-1 standards and/or within the range of site-specific background levels or acceptable soil variability. Hydrocarbon-impacted soil was not observed during field inspection and soil screening activities at the former PWV, ASTs, and dump line locations. Groundwater was not encountered during facility decommissioning or subsequent over-excavation activities. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
