Based on a demonstrated consistent decrease in hydrocarbon impacts at the Location, the increase in air flow in the soil vapor extraction (SVE) system, and continual photoionization detector (PID) readings from the SVE trailer exhaust, Caerus plans to continue to use SVE with bio-vent wells to remediate soil impacts.
