<p>This is a corrective action inspection conducted by a COGCC contractor. The operator has been out of compliance for several years. However, due to an error in the submittal process the inspection was not submitted to the Operator until 2/15/2023 even though the field inspection date was 10/5/2022. Therefore, the CA is set for a future date in the spring of 2023 rather than backdated to when the reclamation should have been conducted. Well location does not meet final reclamation regulations and standards. Reclamation should have been conducted 12/16/19 which is within three months of plugging the well.</p>	huwak	02/13/2023
