Operator shall give an estimate of Common rye occurrence both within the location and in the reference areas. Operator will have to provide two consecutive years without any Common rye observed on and off location before the corrective action to control Common rye will be considered complete. 2) COGCC would like additional quadrat samples or vegetation monitoring taken west of Veg4 and Veg5, as this area appeared to have less germination than the remainder of the interim reclamation areas.
