INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the LILLI UNIT 08-07 wellhead cut and cap. The wellhead was cut and capped per COGCC rules. The flowline was previously abandoned under Midstream operations, therefore, there is no associated Form 44.

Additionally, pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the cut and capping of isolation valves associated with previously P&A'd LILLI UNIT 08-07. These valves were used to isolate the injection well from the gas gathering system.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (C6-C36) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron.

Pertaining to the isolation valves, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, where applicable. Soil samples will be analyzed by a certified laboratory for TPH (C6-C36) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. All samples collected were/will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
