<p><a href="#">COGCC Inspection Report Summary</a></p> <p>On Thursday 2/23/2023 at approximately 10:42 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the KPK Stroh #2 location #319250 in Weld County, Colorado.</p> <p>While there, I observed that the DCP gas sales meter station #232789 appeared to have current product sold. The following possible compliance issues were observed: Immediately cease all gas sales pursuant to Order 1V-863. Further gas sales from this battery is a violation of Rule 219 and Order 1V-863 with a corrective action date of 2/23/2023. Wells associated with this battery are: Stroh #2 API #123-10944, Stroh 28-16 API #123-24147, Stroh 28-10 API #123-24237, Stroh 28-9 API #123-24238, and the Stroh 15-28 API #123-26308.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of the inspection report.</p>	petersont	02/23/2023
