A site investigation will be conducted pursuant to COGCC rule 911 at the Antelope 13-17 (420920) oil and gas location pertaining to the cut/cap of the Antelope 13-17 wellhead (05-123-32748), Antelope D-17 wellhead (05-123-34906), Antelope 12-17 wellhead (05-123-33020), and Antelope H-17 (05-123-34907). On-location flowlines and off-location gas line will be abandoned. See site map exhibit for details.

Grab confirmation soil samples were collected from beneath the above ground oil tank, water vaults, separator, wellhead, and flowline start/end points. A grab confirmation soil sample will be collected from beneath the produced water vault as well as from the side wall that indicated the highest field screening levels. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, metals, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
