INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

After wellbore plugging is complete, equipment will be moved from location, well location will be excavated, wellbore cut and capped 4'-6' below grade. Gas line to meter shed, water line to separator and tank, separator and water tank will be removed from location. During excavation and equipment removal, any soil staining will be noted and soil sample analysis done appropriately.

PROPOSED SAMPLING PLAN**Proposed Soil Sampling**

Due to size of excavation, soil screenings will be taken every 20' along sidewalls of excavation, bottom of excavation next to wellbore, under separator vessel, separator inlet and outlet lines, under produced water tank and area under inlet to produced water tank. If impacts are discovered during field screening, soil sample will be taken from the highest degree of impact from wellbore location, separator location and produced water tank location of full Table 915-1 analysis, IF no impacts are found during field screening, one soil sample will be taken from all three locations for analysis for Table 915-1 Soil Suitability for Reclamation; if that analysis determines parameters above Table 915-1 further analysis may be requested by COGCC. Photographs will be taken of entire location before excavation, during excavation and cut and cap process, soil sample locations, any visible soil staining during excavation and submitted on Supplemental Form 27

Upon the plugging and abandonment of well, abandoned gathering line risers and flowline risers, will be removed within 30 days; surface equipment will be removed within three (3) months of cut and cap date. Well location will then be reclaimed. Where necessary, compaction alleviation, restoration, and revegetation of well site will be performed to the standards as set up under Rule 1003.

All disturbed areas affected will be reclaimed as early and as close to their original condition or their final land use as designated by the surface owner and shall be maintained to minimize erosion. In crop lands, where necessary, added topsoil will be added to the depression and the surface will be left as close to its original contour as possible. The area shall be treated if necessary and practical to prevent invasion of undesirable species and noxious weeds, and to control erosion.

Non crop land will be contoured as close to original as possible to control erosion. The disturbed area will be reseeded in the first favorable season, if necessary. Reclamation of all disturbed areas no longer in use shall be considered complete when all surface is stabilized to minimize erosion and a uniform vegetative cover of at least eighty percent (80%).
