Laboratory analytical indicated a historical release occurred at the Rohr C 15-19 decommissioned wellhead. Three soil samples exceeded COGCC standards for 1,2,4-trimethylbenzene at 0.0126 mg/kg, 1,3,5-trimethylbenzene at 0.015, 1-methylnaphthalene at 0.0259 mg/kg, benzo(a)anthracene at 0.0183 mg/kg, and naphthalene at 0.0073 mg/kg.
