COGCC Inspection Report Summary

On Monday 2/27/2023 at approximately 09:59 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the KPK Matsushima 3-14 location #322557 in Weld County, Colorado.

While there, I observed that the DCP gas sales meter station #23206 appeared to have current product sold. The following possible compliance issues were observed: Immediately cease all gas sales pursuant to Order 1V-863. Further gas sales from this battery is a violation of Rule 219 and Order 1V-863 with a corrective action date of 2/27/2023. Wells associated with the battery are Matsushima 3-14 API #123-11637 and Matsushima 4-19x API #123-23516.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
